SECTION 4: First-aid measures

4.1. Description of first aid measures

Avoid accidental injection. Wash thoroughly after handling. Do not mix Bilovet injection with other injectable solutions as this may cause precipitation of the active ingredients. Do not administer to horses or other equines. Injection of tylosin in equines has been fatal.

- Storage conditions : Store in an indoor area, away from high temperature, and direct sunlight. Do not freeze.
- Storage temperature : 22 °C or below. Product should not be used after the date printed on the container.

Material is not expected to bioconcentrate in aquatic organisms. Biodegradation is expected to be achievable in secondary wastewater treatment plant. Material is not expected to readily evaporate; however, once in the atmosphere it is expected to rapidly degrade (within minutes to hours).

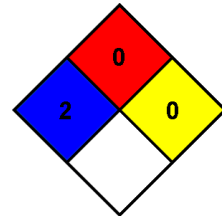
