SECTION 4: FIRST AID MEASURES

4.1. Description of First Aid Measures

SECTION 6: ACCIDENTAL RELEASE MEASURES

6.1. Personal Precautions, Protective Equipment and Emergency Procedures

General Measures: Avoid breathing dust. Avoid all contact with skin, eyes, or clothing. Avoid generating dust. Remove ignition sources. Keep away from heat, hot surfaces, sparks, open flames, and other ignition sources. No smoking.

7.1. Precautions for Safe Handling

Additional Hazards When Processed: Accumulation and dispersion of dust with an ignition source can cause a combustible dust explosion. Keep dust levels to a minimum and follow applicable regulations.

Precautions for Safe Handling: Wash hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work. Avoid breathing dust. Avoid contact with skin, eyes and clothing. Avoid contact with eyes, skin and clothing. Avoid creating or spreading dust. Keep away from heat, sparks, open flames, hot surfaces. – No smoking.
